BE IT FURTHER RESOLVED, that the anticipated revenues as reflected in the Annual Budget are of sufficient amount to meet all proposed expenditures/expenses and all covenants, terms and provisions as stipulated in the Fire District's outstanding debt obligations, capital lease arrangements, service contracts, and other pledged agreements; and

The tax levy in this budget is \$83,883, which represents an increase from 2020 of \$152.

3. **Explain any variances over +/-10% for each line item.** Attach in FAST any supporting documentation that will help to explain the reason for the increase/decrease in the budgeted line item.

There were decreases of more than 10% in Advertising, Supplies, Replacement Equipment, Maintenance & Repairs, and a reduction in the Agreement to Fight Fires. Increases were in Training, Outside Services, Insurance, and LOSAP Contribution. Overall, operating appropriations are less than the prior year, which is a direct result of a reduction in the operating needs of the District. In addition, Deferred charges of \$64,500 represent a FEMA grant that was awarded during the 2020 year.

Complete a brief statement on the impact the proposed Annual Budget will have on the Amount to be Raised by Taxation, the use of the Restricted and Unrestricted Fund Balance(s) and how they are complying with the Property Tax Levy Cap. If Unrestricted Fund Balance is reduced by more than 10%, explain the projected impact on the following year's budget.

The 2021 tax rate will be 19.8 cents per \$100 of assessment. Even though the Unrestricted Fund Balance is projected to decrease by more than 10%, the District has sufficient Unrestricted Fund Balance remaining for future budgets. There will be no tax rate increase in 2021.
